2017 (\$2,500) Scholarship Instructions & Criteria for Applicants

Instructions for Applicants

To apply for a scholarship:

1. Fill out the online Application in its entirety and attest to its accuracy.
2. Attach a scanned copy of your unofficial transcript in .pdf format.
3. Obtain recent Letters of Recommendation from a minimum of two (2) different individuals (one must be from a teacher/professor; the other(s) must be from someone not related to the applicant) sent directly to NYWEA, 525 Plum Street, Suite 102, Syracuse, NY 13204. Letters must be received by February 28, 2017.
4. Submit your completed online application no later than February 28, 2017. Awards will be announced by **June 20th**.
5. Additional details are provided on the "Scholarship Policy & Procedure" page (refer to NYWEA website).
6. All applicants must be New York State residents.

The New York Water Environment Association will be offering a total of twelve scholarships of \$2,500 each in the general high school, student chapter and children of member categories.

Scholarship - Children of NYWEA Members

\$2,500 scholarships are available for children of NYWEA Members.

Eligibility Requirements:

- A parent or student who has been a member in good standing of the NYWEA for at least one year.
- The applicant must enroll as a full-time student in an environmentally related program that allows them to pursue a professional career in the environmental field.
- High school senior and must enroll at a college or university by September 2017, or a student in good standing at a college or university and will begin the Sophomore, Junior or Senior year by September 2017.

Scholarship - NYWEA Student Members

\$2,500 scholarships are available for student members who attend a college or university with a NYWEA student chapter.

Eligibility Requirements:

- A student enrolled in a college or university that has a NYWEA student chapter.
- The applicant must be enrolled as a full-time student in an environmentally related program that allows them to pursue a professional career in the environmental field.
- A student in good standing at a college or university and will begin the Sophomore, Junior or Senior year by September 2017.

Scholarship - High School Students Pursuing Environmental Studies

\$2,500 scholarships are available for high school students who will be enrolled in an environmentally related program in a four year college.

Eligibility Requirements:

- High School Senior in good standing, who has applied to a college or university with the interest of pursuing an environmental career.
- Student winner must show proof of enrollment in the environmentally related program at the four year college or university in September 2017 to receive a scholarship check.
